Barry Posen Appointed Next Henry A. Kissinger Chair in Foreign Policy and International Relations




Barry Posen has been appointed the next Henry A. Kissinger Chair in Foreign Policy and International Relations at the Library of Congress John W. Kluge Center. His 6 month residence will begin on September 6, 2016. At the Kluge Center, Posen will study the implications of multipolar international order to the United States. Kissinger scholars at the Library of Congress are appointed annually by the recommendation of a selection of representatives from the academic community and foreign-policy experts.

M. Taylor Fravel Awarded Prestigious Carnegie Fellowship



The Carnegie Foundation of New York has awarded M. Taylor Fravel as the Andrew Carnegie Fellow for the 2016-17 academic year. This award supports research and writing on challenges for U.S. democracy and international order and is awarded to scholars in the social sciences and humanities. During his fellowship, Fravel will begin a new project focused on maritime disputes in Asia. The award, worth up to \$200,000 will allow Fravel to focus on presenting management tools to help prevent future conflict.

George W. Rathjens, 90, Professor Emeritus of Political Science



George W. Rathjens, one of SSP's founders, passed away on Thursday, May 26, 2016. Prior to coming to MIT he had a distinguished career in government service including the Department of State and the Department of Defense. He is best known for his contributions to the theory and practice of nuclear arms control. As a trained scientist he was able to participate in policy discussions with a fundamental understanding of the weapons and technologies at issue. He was a major participant in the controversial debate in the late 1960s and early 1970s on the wisdom of deploying ballistic missile defenses. Among other

achievements, he was the Secretary General of Pugwash (1998-2002), the international nongovernmental organization dedicated to bringing 'scientific insight and reason to bear' on the risks posed by nuclear weapons. For many years he had been an active participant in that organization, which won the 1995 Nobel Peace Prize. He was also intensely interested in the principal international security problems of the 1990s—humanitarian intervention, sovereignty, and human rights, and under his leadership Pugwash took up these issues in a series of conferences. Professor Rathjens was held in deep affection by his graduate students and colleagues.
